METHOD OF RECRUITMENT:

Selection shall be made based on following Criteria.

For eligible applicants recruitment will be made by awarding 90% of marks for marks obtained in qualifying examination and 10% marks of age weightage. . weightage for age will be reckoned from 18 years of age of the candidate. 0.5 marks will be awarded for one completed year of age with a maximum of 10 marks.

Provisional List, Merit Lists will be prepared base on the above said criteria, and displayed on Kumuram Bheem Asifabad district official website time to time www.asifabad.telangana.gov.in for transparency.

Selection List will be prepared from the finalized Merit list duly following the Rule of Reservation (Roster Matrix) and presidential order.
